

DDRC meets your many needs in ways that are important to you!

DDRC provides services and support to people of all ages with intellectual and developmental disabilities (I/DD) and their families. Contact us to discover your possibilities! We offer services in almost every aspect of people lives:

Early Intervention (EI) supports families of children from birth up to age 3, at no cost, living in Jefferson, Clear Creek, Summit, and Gilpin Counties. Evaluations and therapies (occupational, speech, physical, socialemotional, etc.) help children with developmental delays during the crucial years of development. We go beyond just providing therapy and case management services to your child. We work with your entire family, helping you learn how to best support your child and advocate for their needs.

Behavioral Health Services provide

community-based Applied Behavior Analysis (ABA) services to adults enrolled in a Health First Colorado (Medicaid) Home and Community Based Services (HCBS) waiver, and psychiatry services for individuals 14 years of age and older with a developmental delay enrolled in the Health First Colorado state plan benefit.

Pediatric Behavioral Health Clinic provides on-site ABA services for children 20 years of age and younger, enrolled in Health First Colorado's Early and Periodic Screening, Diagnostic and Treatment (EPSDT) benefit. This helps children develop skills and behaviors to be successful and well-adapted in their daily living.

Therapeutic Learning/ Recreation services support opportunities for learning and activities that help people lead lives that are physically, socially, and emotionally fulfilling. Activities include things such as restaurant outings, cooking /nutrition classes, museums/theatre, movies, Special Olympics, and unified sports.

Self Determination Initiative provides funding to individuals with an IDD/DD to help support developing a new skill, take initiative towards a new goal, and/or move towards a dream of theirs that will promote increased independence and selfdetermination.

Jefferson County Unmet Needs

Funding provides funding for a variety of services and supports which are related to a person's developmental disability and are above and beyond typical child rearing or daily living expenses.

Provider Support Funding Program

permits providers access to funding to address barriers to unmet needs and enhance, expand and/or innovate services.

DDRC Health First Colorado (Medicaid) HCBS IDD/DD Waiver Services

Day Programs provide small groups of participants opportunity to work towards individual goals and explore their interests in the community or at one of day program sites in Arvada and Lakewood. People can plan their activities, learn, and socialize. Transportation is available for designated transportation areas.

Support Services help adults and children with daily living and respite. Daily living supports include assistance with cooking, cleaning, household tasks, shopping and meal planning, budgeting and bill paying, and accessing the community, and mentoring for people to develop self-advocacy.

Technology Supports offers training with computers, tablets, phones, software, and internet safety, which helps people in their personal and work lives. Training and teaching happens in our tech lab, in the home, or in the community.

Residential Services provides support in apartments, group residences, and host homes. DDRC staff and host home providers guide health, safety, and daily living needs, support the individual's interests, assists with medical appointments, and help individuals create an environment that they are happy to call home.





Employment Services and Benefits

Planning offers supports to individuals to find and grow in a career, including helping them understand how working interfaces with their government benefits. Other services include interest and skills assessments, job explorations, skill development, resume and interview preparation, and help in onboarding and navigating with their employer.



Family Care Giver provides individuals and families the opportunity to choose a family member or designee to provide personal care services and support with daily living for you or your loved one enrolled in an HCBS waiver. DDRC makes this possible as the approved employer of the caregiver. Services vary upon waiver but may include assistance with cooking, cleaning, shopping, meal planning, and accessing the community.
