- B. In accordance with Section(s) 5.B.v. of the Original Contract referenced above, the State hereby exercises its option to Increase the quantity of the Services at the rates stated in the Original Contract, as amended.
- C. The Contract Maximum Amount table on the Contract's Signature and Cover Page is hereby deleted and replaced with the Current Contract Maximum Amount table shown above.

### 3. OPTION EFFECTIVE DATE:

The effective date of this Option Letter is upon approval of the State Controller or July 1, 2025, whichever is later.

### 4. NOTE FOR CONTRACTOR:

This Option Letter maintains the same level of funding as State Fiscal Year 2025. All services and rates remain the same. CDEC is issuing this temporary Option Letter to prevent any contracts from expiring. Contractor will be allowed to draw from the GAE for direct services until the contracts are executed by September 1, 2025 per guidance found in Exhibit C – Additional Provisions, Section 11.

Contractor will have until July 16, 2025 to review their budget and submit their approval to the CDEC.

For the months of July and August, Contractor may bill the GAE to cover the direct services costs. Once the State Fiscal Year 2026 Amendment is executed funds will be added for direct services.
